Need for Supported Housing (NSH)

The Supported Housing Need and Choice Evaluation is an innovative systematic statewide initiative to document the Need for Supported Housing for persons living with SPMI who meet the ADA settlement criteria.

The Supported Housing Need and Choice Evaluation supports DBHDD's goal of:

- Providing access to supported housing and facilitating informed choice
- Promoting community integration
- Reaffirming that housing is essential to an individual's recovery process

Need for Supported Housing (NSH)

- ■The tool is a web based application that facilitates a process of providing informed choice for supported housing based on complete information, including the needs, preferences and the appropriate, available housing resources within the community where the individual would like to reside

 - Access Points: DBHDD Hospitals, CSU, ACT, CM/ICM, CST, CRR, CRA, CCPS (Tier 1,2 and 3), PATH
 - Eligible Individuals will have a housing goal as part of their Individual Recovery Plan (IRP)
 - Individuals enrolled and eligible for community based Adult Mental Health Services will work with a contracted service provider to actualize their housing plan and achieve their housing goals
 - Individuals are prioritized for specific housing related resources
